DURING THIS FISCAL YEAR, ACTS RECEIVED 818 REFERRALS OF HOUSEHOLDS REQUESTING ASSISTANCE. OF THAT NUMBER, ACTS WAS ABLE TO FINANCIALLY ASSIST 345 HOUSEHOLDS. THESE 345 HOUSEHOLDS INCLUDED 864 PEOPLE OF WHOM 357 WERE UNDER THE AGE OF 18. AN ADDITIONAL 408 OTHER HOUSEHOLDS RECEIVED SOME SORT OF CASE MANAGEMENT INCLUDING REFERRALS TO OTHER AGENCIES OR ORGANIZATIONS THAT WOULD BE MORE APPROPRIATELY ALIGNED FOR THEIR SPECIFIC NEEDS. ACTS ALSO ACTIVELY COLLABORATES WITH OTHER ORGANIZATIONS WORKING TO PROVIDE FOOD AND CLOTHING TO OUR CLIENTS. THIS PAST FISCAL YEAR, ACTS PROVIDED \$88,532 IN RENTAL ASSISTANCE;
